Title: Awards section By-Law update

Purpose: To update the by-laws to remove the Awards section from the By-Laws.

Text:

Section 1: Whereas, each year GSBA accomplishes different tasks and strives to recognize members for their individual contributions

Section 2: Whereas, the Awards section does not align with the focus of the By-Laws

Section 3: Therefore, be it enacted that Article XXIX: Awards

~~“Section 1: Senator of the Year Award. This award shall be given annually to the Member who goes above and beyond what is expected of a Member to promote and protect the interests of the student body and to serve the Student Senate and GSBA. Selection of the Member of the Year shall be by secret ballot cast by voting members of the Senate at a regular meeting of that body.~~

~~Section 2: Appreciation Award. This award shall be given annually to an individual in the Gonzaga Community such as faculty, administration, or staff members, who best exemplifies service and support to GSBA. Selection of the recipient of this award shall be by secret ballot cast by the members of the Executive Branch, Executive Staff, Class Executives, and the Student Senate.~~

~~Section 3: Service and Loyalty Award. This award shall be given annually to a member of GSBA who has demonstrated outstanding service and loyalty to GSBA. Selection of the recipient of this award shall be by secret ballot cast by the members of the Executive Branch, Executive Staff, Class Executives, and Student Senate.~~

~~Section 4: The Senate Certificate of Appreciation. This award is given to any Member who leaves the Senate in good standing or performs acts above and beyond the call of duty as~~

determined by the Speaker of the Senate.

Section 5: President's Award. This award is given at the discretion of the GSBA President to any individual of the Gonzaga community that has gone unrecognized for their continued service towards the promotion of the GSBA and Gonzaga University mission. They better the lives of all who are a part of Gonzaga University" be removed from the By-Laws to allow for awards catered towards the specific accomplishments of GSBA members.

Section 4: Therefore, be it enacted that this change goes into effect following this year's awards cycle.
